In Hamburg's HafenCity a vast construction project, the "southern Überseequartier", will be created. This mixed-use development is being implemented by Unibail-Rodamco-Westfield, the premier global developer and operator of flagship shopping destinations. Dimensions

Dimensions of the mixed-use project, directly located adjacent to the river Elbe, amount to a total area of 419,000 sqm. This makes southern Überseequartier in Hamburg's HafenCity one of the largest construction projects in Europe. 14 architecturally outstanding buildings will then house 80,500 sqm for retail, 21,000 sqm for gastronomy and entertainment including a multiplex cinema, a cruise terminal with an underground bus station, three hotels, offices with around 2,400 workplaces and approximately 650 apartments. The project budget amounts to more than one billion Euros.

Major highlights for the exciting and unique architecture of the ensemble, developed by 12 renowned architects, include the glazed office towers incorporating a crystalline façade of the versatile building complex located on the waterfront, which serves as a workplace, shopping destination, leisure and culinary hotspot all in one.
